## Principal's Report

- Jungle Gym Update
  - As a reminder, this is construction of the building adjacent to PS29 jungle gym / school yard that has scaffolded our jungle gym
  - Jan 1st projected completion date
  - If not completed after winter break, Dr Fagin will enlist PTA / parents to help support escalation
- PS29 Accessibility Project: 2-3 year project happening in phases
  - Adding elevator + making building accessible to with ramps and elevators + accessible bathrooms
  - Plan is to do work when students are not in building (evenings / some weekend / breaks / school closures / summer)
- 12/1 Projected date to break ground for elevator in school yard
  - Yard will become smaller
  - Line Ups will change for 1st and 5th grade
  - New garden entrance
- 12/23 projected date to break ground on Henry Street side
  - Kane Street yard door closed
  - Prek 223 line to front garden
- Class Size Policy
  - $\circ$   $\,$  New law by Sept 2028 caps 20 kids in K-3 and 23 kids 4th 8th  $\,$
  - PS29 looking at capacity / current enrollment to apply for funding to meet new policy guidelines
  - $\circ$   $\;$  We have the space, need DOE funding  $\;$
  - Working on proposal to submit for next year funding
  - $\circ$   $\,$  Maybe Feb to know if proposal and budget approved but timeline unclear  $\,$
